If a deposit is left on a puppy and we are unable to supply the puppy for any reason, then a full refund of the deposit will be made. Deposits are not refundable for any other reason.

CONDITIONS OF SALE – AGREED BY THE BREEDER AND PURCHASER

1. **SOLD AS A PET:** The puppy is sold as a pet and should not at any time be bred from. The restriction on the registration of progeny with the Kennel Club will not be removed.
2. **SOLD AS HAVING BREED POTENTIAL:** The puppy may only be mated to a suitable registered dog. The resulting puppies shall be reared and sold or re-homed in accordance with K.C. guidelines. No responsibility can be accepted by the breeder should the puppy fail to succeed as a breeding adult. All registration documents are endorsed 'progeny not eligible for registration'. This endorsement can be lifted by the breeder upon receipt of a copy of a acceptable hip score and a adult eye test and DNA test for CEA and TNS if applicable
3. **SOLD AS HAVING SHOW POTENTIAL:** The breeder cannot guarantee the success of the puppy/dog in competitions.

GENERAL NOTES: Bilyara dogs/bitches have been tested for hip displacement and eye deformity. Whilst every effort has been made to eliminate these and other hereditary conditions in our puppies, NO responsibility can be held by the breeder in the event of any condition developing. All puppies/dogs purchased under this agreement, shall not be re-homed or re-sold without the breeder's prior knowledge. The breeder reserves the right, should the situation arise, to take the puppy back, or to participate in agreeing a new home for the puppy, should it be impractical for the puppy to be returned to the breeder.

The Purchaser warrants that they are purchasing for themselves and not as agents for a Third Party. Any endorsements have been pointed out and we fully understand and accept the restrictions. We agree that in the case of a bitch, spaying will not be carried out until after her first season or in the case of a dog, castration will not be undertaken before full maturity at 2 years and then only if necessary.

Our dogs are our hobby; we are not in the business of breeding and selling dogs purely for profit.
